- (1) The Restricted Performance Shares vest based on the Company's return on invested capital for the period that began on January 1, 2011 and ends on December 31, 2013 (the "performance period") as follows. If the Company's return on invested capital at the end of the performance period is in the top decile of the return on invested capital of the Company's peers as published by Bloomberg, then the Restricted Performance Shares will fully vest. If this criteria is not met, then no shares shall vest and the award will be forfeited.
- (2) The Restricted Shares vest in the amount of 1/6th of the grant on each of the six annual anniversaries following the date of grant.
