SIGA Technologies, Inc. (the "Issuer") has certain tax withholding obligations associated with the vesting of restricted stock units ("RSUs") and the consequent issuance of Common Stock of the Issuer. This Form 4 reports the surrender to the Issuer by the Reporting

(1) Person of 27,489 shares of Common Stock -- granted in the form of RSUs approximately two years ago -- in order to satisfy those withholding tax obligations. The Reporting Person reported the initial grant on March 1, 2012.

(2) Represents vesting of one-third of RSUs granted on February 28, 2012. The remaining 1/3 of such RSUs vest on February 28, 2015. Each RSU converts into one share of Common Stock of the Issuer on a one for one basis.
