- (1) Performance Share Units (PSUs) awarded October 29, 2009 had its performance results certified, and then shares vested, on October 15, 2012 at 188% achievement based on total shareholder return (TSR) relative to a peer group. The peer group consisted of the Philadelphia Semiconductor Index (SOXX) companies at grant, with relative TSR measured over a three year measurement period. Each PSU is convertible into one share of Kulicke and Soffa Industries Inc. common stock.
