- (3) On February 22, 2018, the reporting person was granted 5,960 restricted stock units, 25 percent of the restricted stock units became vested on February 22 2019, an additional 25 percent of the restricted stock units became vested on February 22, 2020, an additional 25 percent of the restricted stock units will vest on February 22, 2021, and the remaining balance of 25 percent of the restricted stock units will vest on February 22, 2022.
