The value of each unit was based on the fair market value of Visteon common stock as of June 9, 2015. No shares of common stock were acquired or sold in connection with the vesting of these Restricted Stock Units.

Each Restricted Stock Unit will be converted and distributed to me, without payment, in stock or cash following termination of service or upon a change in control, and based upon the then current market value of a share of Visteon common stock.
