(1) Represents a "net exercise" of outstanding stock options. The reporting person received 15,673 shares of common stock on net exercise of option to purchase 30,000 shares of common stock. The Company withheld 14,327 shares of common stock underlying the option for payment of the exercise price and tax withholdings, using the closing stock price on August 1 of \$99.61, pursuant to the terms of the 2013 Equity Incentive Plan.

(2) The stock option award (combined incentive stock option and non-qualified stock option) vested as to 1/4th of the total number of shares on September 26, 2014 and 1/8th of the shares vest every six months thereafter.
