EXPLANATORY NOTE: DEREGISTRATION OF SECURITIES

On November 23, 2005, Intellisync Corporation, a Delaware corporation (the Company), filed a registration statement on Form S-8 (No. 333-129926) (the Registration Statement), which registered 1,200,000 shares of common stock (as such amounts may have increased for any stock splits, stock dividends, or similar transactions occurring subsequent to the original filing date), of the Company, par value \$0.001 per share (the Common Stock), of which 500,000 shares of Common Stock were to be offered or sold under the 1998 Employee Stock Purchase Plan (the Plan), 500,000 shares of Common Stock were to be issued pursuant to the options granted under the Eichler Retention Stock Option Agreement and 200,000 shares of Common Stock were to be issued pursuant to the options granted under the Hankins Retention Stock Option Agreement (together with the Eichler Retention Stock Option Agreement, the Agreements).

On February 10, 2006 (the Merger Date), pursuant to an Agreement and Plan of Merger, dated as of November 15, 2005, among the Company, Nokia Inc., a Delaware corporation (Nokia), and Jupiter Acquisition Corporation, a Delaware corporation and wholly-owned subsidiary of Nokia (Merger Sub), Merger Sub merged with and into the Company, and the Company became a wholly-owned subsidiary of Nokia (the Merger). On February 10, 2006, the Company filed a certification and notice of termination of registration on Form 15 with respect to the Common Stock.

As a result of the Merger, the Company has terminated all offerings of the Company's securities pursuant to its existing registration statements, including the Registration Statement. Accordingly, pursuant to the undertaking contained in the Registration Statement to remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the offering, the Company is filing this Post-Effective Amendment No. 1 to the Registration Statement to deregister all the shares of the Company's Common Stock reserved for issuance under the Plan and the Agreements which remain unissued or unvested, as applicable, on the Merger Date.
