- Genentech entered into an Agreement and Plan of Merger, dated April 19, 2006, with Alteon, Inc., Alteon Merger Sub, Inc., and HaptoGuard, Inc. under which we agreed to restructure our nonvoting Preferred Stock position in Alteon in exchange for milestone (1) payments, royalties and a right of first negotiation on certain compounds. As part of the merger which closed on July 21, 2006, a certain portion of our Preferred Stock was converted into 13,492,349 shares of Alteon common stock, a certain portion of our Preferred Stock was transferred to HaptoGuard, Inc. and our remaining Preferred Stock was canceled.
