Penn National Gaming, Inc. (Penn) announced today that Gaming and Leisure Properties, Inc. (GLPI), the real estate investment trust that would be publicly traded and hold substantially all of Penn 's real property assets following the proposed separation of Penn 's operating assets from our real property assets, has filed a free writing prospectus with the Securities and Exchange Commission. GLPI common stock may not be sold nor may offers to buy be accepted prior to the time the registration statement becomes effective and this Current Report shall not constitute an offer to sell or the solicitation of an offer to buy shares of GLPI common stock.
