On April 21, 2006, July 21, 2006 and October 20, 2006, dividends on these shares were paid and automatically reinvested in additional shares of Class A Common Stock for the benefit of the Reporting Person by the Compensation Plan Trust in the amounts of 202.6908 shares, 211.6064 shares and 185.8181 shares, respectively.
