- (4) These options generally become exercisable in equal installments on each of the first three anniversaries of March 4, 2019.
- (5) On July 7, 2016, the issuer effected a 1-for-10 reverse stock split. The amount of securities beneficially owned and the exercise price of warrants have been adjusted to reflect the reverse stock split.
- (6) These warrants became exercisable in equal installments on each of the first three anniversaries of August 7, 2014.
