- (6) Restricted stock unit award expires upon reporting person's termination of employment.

On February 27, 2018, the reporting person was granted performance restricted stock units, the vesting of which was subject to both

- (7) continued service and the attainment of certain AFFO, Revenue and EBITDA targets for 2018. The Compensation Committee certified the degree to which the targets were achieved, therefore 50% of the award vested on February 25, 2019, 25% will vest on February 15, 2020 and the remaining 25% will on February 15, 2021, subject solely to continued service.
