This Schedule 13G/A is filed by the Berry Hattie Stein 2018 Grantor Retained Annuity Trust (the GRAT ), which is administered by four (4) trustees, including Jay Stein, who is also the grantor, and three (3) additional independent trustees. A majority of the three (3) independent trustees has the power to vote, or direct the voting of, the shares held by the GRAT. A majority of all four (4) trustees has the power to dispose of, or direct the disposition of, the shares held by the GRAT, and, additionally, Jay Stein, as grantor, may exercise a power of substitution and reacquire the shares from the GRAT by substitution of other property of an equivalent value.
2. In accordance with the provisions of the GRAT, Jay Stein elected to substitute certain assets for 4,500,000 shares of common stock of Stein Mart, Inc. (the Substitution ). As a result of the Substitution, the GRAT no longer holds any shares of common stock of Stein Mart, Inc.
