Stockholder Meeting Notice The Marchex, Inc. 2017 Annual Meeting of Stockholders will be held on Monday, August 21, 2017, at 10:00 a.m. Pacific Time, at Marchex, Inc., 520 Pike Street, 1211 Building Conference Center, 12th Floor, Seattle, Washington. Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations. The Board of Directors recommends a vote FOR all nominees in Proposal 1, FOR Proposals 2-4 and 6, and 3 YEARS for Proposal 5: 1. To elect four (4) individuals to serve on our Board of Directors for the ensuing year and until their successors are elected; 2. To ratify the appointment of Moss Adams LLP as our independent registered public accounting firm for the fiscal year ending December 31, 2017; 3. To approve the adoption of an amendment to our amended and restated bylaws to provide that the courts located within the State of Delaware will serve as the exclusive forum for the adjudication of certain legal disputes; 4. To approve, by a non-binding advisory vote, the compensation paid to our named executive officers; 5. To select, by a non-binding advisory vote, the frequency at which stockholders will be asked to approve the compensation paid to our named executive officers; 6. To reapprove provisions of the 2012 Stock Incentive Plan to enable the Company to deduct in full certain plan-related compensation under Section 162(m) of the Internal Revenue Code of 1986, as amended; and 7. In accordance with the discretion of the proxy holders, to act upon all matters incident to the conduct of the meeting and upon such other matters as may properly come before the meeting.
