- (1) Open market sale pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on May 19, 2016, at which time the trading schedule, including sale periods and the number of shares to be sold, was established in accordance with Rule 10b5-1 of the Securities Exchange Act of 1934, as amended.
