**DEREGISTRATION OF SECURITIES**

This Post-Effective Amendment No. 1 to Form S-8 relates to the Registration Statement on Form S-8 (Registration No. 33-81066) (the Registration Statement ) filed with the Securities and Exchange Commission (the SEC ) on July 1, 1994 by G-III Apparel Group, Ltd. (the Company ).
