Restrictions lapse as to 962 on each of March 31, 2015, June 30, 2015, September 30, 2015; 2087 on each of April 1, 2015, July 1, 2015, October 1, 2015, January 1, 2016, April 1, 2016, July 1, 2016, October 1, 2016, January 1, 2017, April 1, 2017, July 1, 2017, October 1, 2017; and 945 shares on January 1, 2018.
