- (1) Each restricted stock unit represented a contingent right to receive one share of TechTarget Inc.s common stock.
- (2) These shares of common stock vested and were delivered upon the satisfaction of a certain performance condition in a performance-based restricted stock unit.
- (3) The reported sale was made automatically pursuant to a trading plan entered into by the reporting person pursuant to Rule 10b5-1 under the Securities Exchange Act of 1934.
- (4) The reported transactions were executed at sales prices ranging from \$8.12 to \$8.25.
