Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On March 24, 2014, the Board of Directors of Trinity Industries, Inc. (the "Company") elected Dunia A. Shive as an independent member of the Company's Board of Directors, effective immediately. Although she has not been appointed to any committees at this time, it is currently anticipated that she will be appointed to the Audit Committee of the Board of Directors at a future date. Ms. Shive will receive the Company's standard non-employee director compensation. Ms. Shive was awarded 813 restricted stock units that convert to common stock upon retirement from the Board and vest immediately prior to the 2014 Annual Meeting. Ms. Shive has no arrangement or understanding with any person regarding her selection as a director of the Company.
