All shares were converted in the merger into (i) the right to receive a cash payment of \$5,231,714.90, representing 1,413,977 shares of stock multiplied by \$3.70, the consideration for shares of Seitel's common stock in the merger, and (ii) 1,108 shares of the common stock of Seitel Holdings, Inc., in exchange for 117,342 of the shares of common stock not converted into cash.
