Item 7.01. Regulation FD Disclosure.

On November 30, 2011, OpenTable, Inc. (the “Company”) issued a press release announcing that its board of directors has approved a \$50 million share repurchase program. Any share repurchases made pursuant to the program will be made from time to time in the open market, in privately negotiated transactions or otherwise, in accordance with applicable securities laws and regulations. The timing and amount of any shares repurchases will be determined by the Company’s management based on its evaluation of market conditions, the trading price of the stock, regulatory requirements and other factors. The share repurchase program may be suspended, modified or discontinued at any time at the Company’s discretion without prior notice. A copy of the press release is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
