- Shares purchased in the Evolving Systems, Inc. Employee Stock Purchase Plan through regular payroll contributions. The purchase price of stock acquired pursuant to rights granted under the Plan is the lesser of: An amount equal to eighty-five percent (85%) of the fair market value of the stock on the Offering Date (January 1, 2009); or an amount equal to eighty-five percent (85%) of the fair market value of the stock on the Purchase Date (March 31, 2009). The purchase price of these shares was \$0.73 per share. This report is being filed voluntarily as the transaction is exempt from Section 16 reporting under Rule 16b-3(c).
- This line corrects the transaction entry of August 15, 2007. The Reporting Person bought 1,000 shares of common stock on August 15, 2007; on that same date his wife bought 16,000 shares of common stock which were inadvertently attributed to him as direct ownership. They are, however, owned indirectly.
