(CAYMAN) and Special Situations Private Equity Fund, L.P. (PE and together with QP and (1) CAYMAN, the Funds). As the investment adviser to the Funds, AWM holds sole voting and investment power over 934,212 shares of Common Stock of the Issuer (the Shares) and 421,699 Warrants and 481,733 Warrants* held by QP, 1 Shares held by CAYMAN and 335,000 Shares and 421,699 Warrants held by PE.
- (2) Austin W. Marxe (Marxe), David M. Greenhouse (Greenhouse) and Adam C. Stettner (Stettner) are the controlling principals of AWM.
