Item 5.07. Submission of Matters to a Vote of Security Holders.

The Annual Meeting was held to: (1) elect five directors to serve until the next Annual Meeting of Shareholders; (2) advisory approval of named executive officer compensation; and (3) ratify the selection of Grant Thornton LLP as our independent registered public accounting firm for the fiscal year ending March 31, 2016.

Proxies for the meeting were solicited pursuant to Section 14(a) of the Exchange Act. All of our directors, including the outgoing and newly-elected directors, attended the meeting. There were 4,866,181 shares of common stock entitled to vote with a majority represented at the meeting. The Board of Directors recommended a vote for each of the director nominees, and for Proposals 2 and 3. There was no solicitation in opposition.

Final voting results were as follows:
