Bally Technologies, Inc. (the Company) hereby requests an extension of time to file its Quarterly Report on Form 10-Q for the fiscal quarter ended December 31, 2007 (the Second Quarter 10-Q). The Company dedicated significant resources towards the preparation and filing of its Quarterly Report on Form 10-Q for the fiscal quarter ended September 30, 2007 (the First Quarter 10-Q), its Annual Report on Form 10-K for the fiscal year ended June 30, 2007 (the 2007 10-K) and its definitive proxy statement for the company's upcoming annual meeting of shareholders (the Proxy). As a result of the delay in filing the 2007 10-K and the First Quarter 10-Q and the significant amount of time and resources necessary to prepare the Proxy, the Company requires additional time to complete its Second Quarter 10-Q. The Company continues to dedicate significant resources to the preparation of the Second Quarter 10-Q and the related financial statements and expects to file the Second Quarter 10-Q within the five day extension provided hereby.
