- (1) On 06/03/2011, Reporting Person was awarded a number of performance-based restricted stock units (RSUs), within a preset range, with the actual number contingent upon the achievement of certain performance criterion. If certain performance criterion is achieved, fifty percent (50%) of the grant vests on the third and fourth anniversaries of the date of grant, subject to applicable taxes upon delivery.
- (2) Disposition of shares exempt under Rule 16b-3 as payment of tax liability to Company incident to vesting of restricted stock share award. Price reflects weighted average sales price; actual sales prices ranged from \$10.34 to \$10.38. The reporting person undertakes to provide, upon request by the Commission staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares purchased or sold at each separate price.
- (4) Includes the following: (1) 12,500 unvested Restricted Share Units, which will vest on February 28, 2015; (2) 10,000 unvested Restricted Share Units, which will vest on June 3, 2015; (3) 37,500 unvested Restricted Share Units, which will vest in two equal annual installments beginning on May 17, 2015; and (4) 56,250 unvested Restricted Share Units, which will vest in three equal annual installments beginning on May 21, 2015.
