On 06/15/2010, Reporting Person was awarded a number of performance-based restricted stock units (RSUs), within a preset range, with (1) the actual number contingent upon the achievement of certain performance criterion. If certain performance criterion is achieved, fifty percent (50%) of the grant vests on the third and fourth anniversaries of the date of grant, subject to applicable taxes upon delivery.

(2) Includes the following: (1) 20,000 unvested Restricted Share Units, which will vest on June 3, 2015; (3) 25,000 unvested Restricted Share Units, which will vest in two equal annual installments beginning on May 17, 2015; and (4) 82,500 unvested Restricted Share Units, which will vest in four equal annual installments beginning on May 21, 2015.

(3) Each unvested Restricted Stock Unit represents a contingent right to receive one unrestricted, fully transferable share for each vested Restricted Stock Unit which has not previously forfeited.
