(1) Direct beneficial holdings after the sale total 14,610 shares which include vested options to acquire 11,000 shares of the Registrant's Common Stock (\$0.50 par value) at the following prices: 5,000 shares @ \$8.24 per share and 6,000 shares @ \$7.00 per share.

The shares vest 1/4 each year from grant date for four consecutive years as follows: 6,000 options @ \$7.00 were granted on 11/20/2003 and expire on 11/20/2013; 10,000 options @ \$8.24 were granted on 7/12/2006 and expire on 7/12/2011; 7,500 options @ \$4.35 were granted on 12/10/2007 and expire on 12/10/2012. Of these 23,500 shares, 11,000 are vested.
