Item. 1.01. Entry into a Material Definitive Agreement.

On November 16, 2012, AmerisourceBergen Corporation (the Registrant ) entered into a Third Amendment to Amended and Restated Receivables Purchase Agreement, dated as of November 16, 2012, among Amerisource Receivables Financial Corporation ( ARFC ), as Seller, AmerisourceBergen Drug Corporation ( ABDC ), as Servicer, the Purchasing Agents and Purchasers party thereto and Bank of America, National Association, as Administrator to extend the maturity date of its \$700 million accounts receivables securitization facility to November 16, 2015.

The securitization facility is available to provide additional liquidity and funding for the ongoing business needs of the Registrant and its subsidiaries. The securitization facility is based on the accounts receivables originated by ABDC for the sale of pharmaceuticals and other related services. Pursuant to the securitization facility, ABDC sells its accounts receivables to ARFC. ARFC may sell interests in the accounts receivables purchased from ABDC to the various purchaser groups party to the securitization facility, paying interest on amounts outstanding under the facility. Bank of America, National Association, serves as the administrator of the securitization facility. The securitization facility has a base limit of \$700 million, with an option to increase the commitments of the participating banks, subject to their approval, by an additional \$250 million for seasonal needs during the December and March quarters. The Registrant serves as the performance guarantor of ABDC s obligations as originator and servicer under the securitization facility.
