On March 19, 2012, the Company's Board has appointed Dr. John Thomas as Director and Mr. Tony Gilman and Dr. Stefan Kruse as Advisors of the Company. Dr. Thomas will receive an honorarium of CDN \$2,000 for the first year of his participation on the Board and Mr. Gilman and Dr. Kruse will receive CDN \$1,000 for their first year participation as Advisors.

On April 14, 2011, the Company had adopted the 2011 Stock Option Plan. Based on this original Stock Option Plan, on March 19, 2012, the Company has granted additional 450,000 stock options to Directors and Advisors of the Company. The exercise price of the stock options is \$0.15, of which are 225,000 options vest immediately, 225,000 options vest on August 15, 2012. The options expire March 19, 2017.
