Pursuant to the issuer's Board of Directors Compensation Plan, the Board of Directors granted \$100,000 of common stock to each  
(1) non-employee director under the issuer's 2015 Equity Incentive Plan, based on the \$18.61 closing price of the stock on June 5, 2018 as quoted on the NASDAQ Global Select Market.

Pursuant to the issuer's Board of Directors Compensation Plan, the reporting person elected to receive \$110,000 of restricted stock issued  
(2) under the issuer's 2015 Equity Incentive Plan, in lieu of cash compensation. The restricted stock issued to the reporting person is based on the \$18.61 closing price of the common stock on June 5, 2018, as quoted on the NASDAQ Global Select Market. The restricted stock vests in four equal installments on September 5, 2018, December 5, 2018, March 5, 2019 and June 5, 2019.
