- (1) On 1/29/2018, a total of 1,833 shares of restricted common stock of the Issuer, a portion of such restricted shares having been awarded to the Reporting Person on each of 1/28/2015, 1/27/2016 and 1/25/2017, became vested and unrestricted. A portion of the vesting shares was withheld by the Issuer in order to satisfy the Reporting Person's tax liability.
- (2) This amount includes 4,134 shares of restricted common stock which vest over time, and 1,250 shares of restricted common stock which vest based on share price appreciation, both of which were previously reported.
- (3) This Form 4/A amends and replaces in its entirety the Form 4 filed by the Reporting Person on 1/31/2018 (the "Original Filing"). This report on Form 4/A is being filed solely to correct the inadvertent over-reporting of the Reporting Person's total holdings of common stock by 73 shares (the "Over-Reported Shares"). The Over-Reported Shares were also inadvertently included in three Forms 4 filed by the Reporting Person after the Original Filing.
