**For the quarter ended June 30, 2011, the Company anticipates that its net loss was approximately \$356,000 compared to a net loss of approximately \$2,454,000 for the prior year period, with the difference primarily reflecting revenues in the current year period from the Company's June 2011 option agreement with Les Laboratoires Servier, a reduction in research and development expenses due to the timing of clinical development outlays, and a reduction in general and administrative expenses due to minimized use of outside consultants.**
