Alan Treffer is the beneficial owner of 39,482,248 shares of Common Stock which includes 118,000 shares held by the Treffer Foundation, of which Mr. Treffer is a trustee. Mr. Treffer has no pecuniary interest in the 118,000 shares of Pegasystems Inc. stock which are held by the Treffer Foundation. Mr. Treffer retains voting and dispositive control over such shares.
