This Registration Statement on Form S-8 is filed by Sirius XM Radio Inc., a Delaware corporation (the Company), to register an additional 11,000,000 shares of the Company's common stock, par value of \$0.001 per share and an indeterminate number of plan interests, issuable under the Sirius Satellite Radio Inc. 401(k) Savings Plan (the Plan).
