**Today's Announcement**

**What was announced today (March 14, 2016)?**

DuPont has named Randy Stone as president of its Performance Materials business effective immediately, succeeding Patrick E. Lindner who has resigned from the company to accept another position. Randy will report to DuPont Executive Vice President Marc Doyle.

**What can you tell us about Randy Stone?**

Randy Stone joined DuPont in 2007 and has served in progressive leadership roles for the DuPont Dow Elastomers Joint Venture and DuPont Performance Elastomers business, the latter while located in Shanghai, China. Randy also served as Director, Investor Relations and most recently in DuPont Performance Materials as Global Business Director - High Performance Solutions. He received a Bachelor's Degree in Economics from South Dakota State University and an MBA from Lehigh University.

**What makes Randy best suited to lead DuPont Performance Materials?**

Randy Stone brings a depth of business knowledge and global leadership skills combined with a record of success in executing for superior business results. He will help drive growth through a strong innovative pipeline of products that meet customer needs, and will make an outstanding leader at an important time for Performance Materials. Randy has a passion for leading others and his energy and enthusiasm for building strong customer relationships is a plus.

**What happened to Pat Lindner?**

Pat resigned from DuPont and has accepted an offer from W.L. Gore. We thank Pat for his many contributions to DuPont over the past 20 years. We wish him continued success in his career.

**Who is taking over Randy Stone's role as director for the High Performance Solutions business unit within DuPont Performance Materials?**

Randy's replacement will be named at a later date.

**Do you anticipate this impacting the level of service you provide to me?**

DuPont Performance Materials remains committed to innovation, sustainability and collaboration with our customers. For customers, it will be business as usual – the continuity and stability of our customer relationships is our top priority.

**What does the merger with Dow and intended subsequent separation into three independent companies mean for customers in DuPont Performance Materials?**

For DPM customers, it is business as usual – the continuity and stability of our customer relationships is our top priority. Until the merger closes, which is expected sometime in the second half of this year, we will continue to operate as two independent companies. The intended separation into three strong, independent companies is not expected to occur until 18-24 months after that.

Once the intended separation is complete, DuPont's Performance Materials segment, as well as Dow's Performance Plastics, Performance Materials and Chemicals, Infrastructure Solutions, and Consumer Solutions (excluding the Dow Electronic Materials business) operating segments will come together to form a low-cost, innovation-driven industry leader with an estimated revenue generation of approximately \$46B.<sup>1</sup> The Material Science business will provide customers in packaging, transportation, and construction with a broad and deep portfolio of cost-effective offerings.

In connection with the proposed transaction, on March 1, 2016 DowDuPont Inc. (f/k/a Diamond-Orion HoldCo, Inc.) ( DowDuPont ), filed with the Securities and Exchange Commission ( SEC ) a preliminary registration statement on Form S-4 that includes a joint proxy statement of The Dow Chemical Company ( Dow ) and E. I. du Pont de Nemours and Company ( DuPont ) and that also will constitute a prospectus of DowDuPont. These materials are not final and may be amended. Dow, DuPont and DowDuPont may also file other documents with the SEC regarding the proposed transaction. This document is not a substitute for the joint proxy statement/prospectus or definitive registration statement or any other document which Dow, DuPont or DowDuPont may file with the SEC.
