(d) Appointment of New Directors

On November 18, 2016, First Financial Northwest, Inc. (the "Company"), its financial institution subsidiary, First Financial Diversified Corporation ("FFD"), announced that their Boards of Directors had appointed Mr. Richard M. Riccobono to their respective Boards of Directors effective November 17, 2016. The appointment of Mr. Riccobono as a Director of the Company, the Bank and FFD was at the recommendation of each Board's nominating committee. Mr. Riccobono was appointed to serve on the Company's Audit/Compliance/Risk Committee and the Compensation and Awards Committee and was appointed as Chair of the Bank's Internal Asset Review Committee. Mr. Riccobono has not engaged in any transaction with the Company, the Bank of FFD that would be reportable as a related party transaction under the rules of the Securities and Exchange Commission.
