Upon vesting, all fractional shares underlying the vesting tranche of RSUs and Additional RSUs are cancelled.
 - (3) As previously reported, (i) on January 30, 2017, the reporting person was granted 2,756 RSUs pursuant to the Hexcel Corporation 2013 Stock Incentive Plan (the "2013 Plan"), (ii) on January 30, 2018, 925 RSUs and Additional RSUs vested and (iii) on January 30, 2018, 932 RSUs and Additional RSUs vested, leaving 931.81 RSUs and Additional RSUs unvested. On February 12, 2019, the reporting person received dividend equivalents in the form of 1.96 Additional RSUs, based on the \$71.28 market price per underlying share on the dividend payment date.
 - (4) As previously reported, (i) on January 29, 2018, the reporting person was granted 2,104 RSUs pursuant to the 2013 Plan and (ii) on January 29, 2019, 706 RSUs and Additional RSUs vested, leaving 1,411 RSUs and Additional RSUs unvested. On February 12, 2019, the
