(BMV: KOFL; NYSE: KOF), has closed an acquisition agreement with the shareholders of the Guatemalan company “Alimentos y Bebidas del Atlántico, S.A”, a bottler of *Coca-Cola* products, in an all-cash transaction for an amount of US\$ 53.4 million on a cash free and debt free basis.
