**Item 1.02. Termination of a Material Definitive Agreement.**

As noted in the Press Release referenced in this report under Item 8.01, Steel Dynamics, Inc. has redeemed for cash all of its remaining outstanding 7 ¾% Senior Notes due 2016, effective August 31, 2012. The 7 ¾% Senior Notes were issued in the original principal amount of \$500,000,000, pursuant to an Indenture dated as of April 3, 2008, as supplemented and amended (the Indenture ), among Steel Dynamics, Inc. as issuer, certain named guarantor parties thereto, and Wells Fargo Bank, N.A., as trustee. By virtue of Section 8.01(i) of the Indenture, the Company having fully paid all remaining sums payable thereunder, and having delivered all remaining Notes to the Trustee for cancellation, the Company's obligations under the Indenture have now been terminated.

On August 31, 2012, Steel Dynamics, Inc. issued a press release titled Steel Dynamics Announces Redemption of Notes.
