The Reporting Persons may be deemed to be a group as defined in Rule 13d-5(b) under the Exchange Act and, as such a group, may be deemed to beneficially own an aggregate of 4,121,765 shares of the Common Stock, which constitute approximately 8.4% of the outstanding shares of the Common Stock, based on 49,080,114 shares of the Common Stock outstanding as of November 2, 2018 according to the Issuer's Quarterly Report on Form 10-Q for the quarterly period ended September 30, 2018, filed with the Commission on November 7, 2018, on which are based all of the percentages (rounded off to the nearest tenth) of outstanding shares of Common Stock set forth herein. The foregoing and all other amounts of beneficial ownership set forth herein are calculated pursuant to Rule 13d-3 under the Exchange Act ( Rule 13d-3 ).

GAMASE Insured Trust holds 2,526,980 shares of the Common Stock (constituting approximately 5.2% of the outstanding Common Stock) and may be deemed to beneficially own such shares pursuant to Rule 13d-3.

Gala Trust is the sole trustee of GAMASE Insureds Trust and GAMASE Agents Trust, a trust established under the laws of the Republic of Panama ( GAMASE Agents Trust ) which holds 260,751 shares of the Common Stock (constituting approximately 0.5% of the outstanding Common Stock) and may be deemed to beneficially own such shares pursuant to Rule 13d-3, and therefore may be deemed to beneficially own 2,787,731 shares of the Common Stock (constituting approximately 5.7% of the outstanding Common Stock) pursuant to Rule 13d-3.

Regal Trust (BVI) Ltd. ( Regal ) is the sole trustee of CICA Associates Trust, a trust established under the laws of the British Virgin Islands ( Regal Associates Trust ) which holds 232,713 shares of the Common Stock (constituting approximately 0.5% of the outstanding Common Stock) and sole trustee of CICA Policyholders Trust, a trust established under the laws of the British Virgin Islands ( Regal Policyholders Trust ) which holds 1,101,321 shares of the Common Stock (constituting approximately 2.2% of the outstanding Common Stock) and may be deemed to beneficially own all such shares pursuant to Rule 13d-3, and therefore may be deemed to beneficially own 1,334,034

shares of the Common Stock (constituting approximately 2.7% of the outstanding Common Stock) pursuant to Rule 13d-3.

GA&L owns a 100% interest in each of Gala Trust and Regal, and therefore may be deemed to beneficially own 4,121,765 shares (constituting approximately 8.4% of the outstanding Common Stock) pursuant to Rule 13d-3.
