(SSF3) and the general partner of Special Situations Fund III QP, L.P. (SSFQP). Marx and Greenhouse are also members of MG Advisers L.L.C. (MG), the general partner of Special Situations Private Equity Fund, L.P. (SSPE). AWM serves as the investment adviser to SSFQP and SSPE. (SSF3, SSFQP, Cayman, and SSPE will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related

securities and other securities of any kind or nature.

(b) Percent of Class: Messrs. Marxe and Greenhouse beneficially own 12.6% of the shares outstanding. Cayman owns 2.2% of the outstanding shares, SSPE owns 3.4% of the outstanding shares, SSF3 owns 0.0% of the outstanding shares and SSFQP owns 7.0% of the outstanding shares.
