- (3) These Non-Qualified Stock Options were granted on March 4, 2003 pursuant to the 2002 LTIP and the AirGate PCS, Inc. Non-Employee Director Compensation Plan.

- (4) These options provided for vesting in the amount of 100% of the total grant on the first anniversary of the grant date. These options were cancelled in the merger in exchange for a cash payment of \$158,940.00, representing the number of shares subject to the option times the difference between the exercise price of the option and the average closing price of Alamosa common stock for the ten trading days prior to the merger multiplied by 2.87 (\$36.62 per share).

- (5) Convertible into the issuer's common stock on a 1-for-1 basis.

- (6) These Restricted Stock Units (the "RSUs") were scheduled to vest on April 8, 2005, subject to certain conditions as detailed in the AirGate PCS, Inc. Director Compensation Plan. On February 7, 2005, the Company's board of directors approved the full acceleration of vesting of these RSUs, effective immediately prior to the closing of the merger on February 15, 2005. The RSUs were cancelled in the merger in exchange for a cash payment of \$22,997.36, representing the number of RSUs times the average closing price of Alamosa common stock for the ten trading days prior to the merger multiplied by 2.87 (\$36.62 per share).
