(Micro), (iii) 10,128 shares held by LKCM Core Discipline, L.P. (Core), and (iv) 592,326 shares held by LKCM Headwater Investments II, L.P. (HW). LKCM Private Discipline Management, L.P. holds the management shares of PDP, and LKCM Alternative Management, LLC (PDP GP) is its general partner. LKCM Micro-Cap Management, L.P. (Micro GP) is the general partner of Micro. LKCM Core Discipline Management, L.P. (Core GP) is the general partner of Core. LKCM Headwater Investments II GP, L.P. (HW GP) is the general partner of HW. J. Bryan King is a controlling member of PDP GP, Micro GP, Core GP, and HW GP.
