On August 1, 2016 Capricor Therapeutics, Inc., a Delaware corporation (the “Company”), provided an update on its Exosome program. As supported by recent preclinical findings, the Company has determined that the first clinical indication for which it will develop its therapeutic development candidate, CAP-2003, will be within the area of ophthalmology, and this indication will be one among alkali burn injury, ocular graft-versus-host disease, and inflammatory dry eye disease. The recent preclinical findings are included as part of the Company’s investor presentation, which is available on the Company’s website at www.capricor.com.
