(1) On February 17, 2016 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 20,379 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 17, 2019, the remaining 10,189 shares of the originally granted RSAs vested, of which 4,614 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.

(2) Between January 17, 2018 and February 6, 2019, the Reporting Person acquired 2 shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan pursuant to the Dividend Reinvestment feature of the Plan. Also, 1 share was sold from the Reporting Person's Plan account in connection with certain Plan administration actions. This information is based on a Plan statement dated February 6, 2019.
