Item 5.07 Submission of Matters to a Vote of Security Holders.

On May 12, 2011, MicroFinancial Incorporated (MicroFinancial or the Company) held its 2011 Special Meeting of Stockholders in Lieu of Annual Meeting (the Meeting). Two proposals were before the Meeting: (1) The election of two directors, Torrence C. Harder and Fritz von Mering, each to serve until the 2014 annual meeting and until their successors are elected and have qualified; and (2) the ratification of the selection of McGladrey & Pullen, LLP as independent auditors for MicroFinancial for 2011.

Only stockholders of record as of the close of business on April 5, 2011 were entitled to vote at the Meeting. As of April 5, 2011, 14,231,692 shares of common stock of the Company were outstanding and entitled to vote at the Meeting. At the Meeting, 13,238,458 shares of common stock of the Company were represented, in person or by proxy, constituting a quorum.

All of the proposals were approved. The votes with respect to the proposals are set forth below.

(1) Elect Two Directors to Serve until the 2014 Annual Meeting:
