- (1) The RSUs were originally granted as part of Ms. Russo's hiring grant under the Lucent Technologies 1996 Long Term Incentive Plan (the "1996 LTIP"). These RSUs were originally scheduled to vest on January 6, 2007. Pursuant to the provisions of the 1996 LTIP, the vesting of these shares accelerated upon receiving the approval on November 17, 2006 from the Committee on Foreign Investment in the United States, to proceed with the proposed merger transaction between Alcatel and Lucent.
