On February 6, 2016, Tel-Instrument Electronics Corp ("Tel", "Tel-Instrument" or the "Company") (NYSE American: TIK) , reported that it received an initial purchase order totaling \$520,000 from its European Distributor, Muirhead Avionics ("Muirhead") for Mode 5 test sets from the contract awarded by the German military. This is a seven-year procurement contract with anticipated orders for the 2019 calendar year of approximately \$3.5 million in total.
