(1) Accenture SCA is a subsidiary of Accenture Ltd. Subject to certain contractual restrictions, Accenture SCA is obligated, at the option of the Reporting Person, to redeem any outstanding Accenture SCA Class I common shares at a redemption price per share generally equal to the market price of an Accenture Ltd Class A common share at the time of the redemption, subject to an adjustment. Accenture SCA may, at its option, pay the redemption price with cash or by delivering Accenture Ltd Class A common shares.

(2) Options with respect to 10,933 underlying shares vested and became exercisable prior to September 1, 2006. The remaining 5,648 vest and become exercisable on August 31, 2007.

(3) 100% vested and exercisable prior to September 1, 2006.
